

## FOLLOW-UP COVID-19 HISTORY QUESTIONNAIRE, COF QUESTION BY QUESTION (QxQ), VERSION 1.0


### I. GENERAL INSTRUCTIONS

The Follow-up COVID-19 History Questionnaire (COF) is to be completed by the coordinator while interviewing the participant during the 18-month follow-up phone call and 3-year follow-up clinic visit.

#### **NOTE:**

- For the 18-month follow-up phone call, all questions should be answered thinking back to the baseline visit as the last SOURCE contact (not the last 6-month follow-up phone call in which an FUQ is completed).
- For the 3-year follow-up clinic visit, all questions should be answered thinking back to the 18-month follow-up phone call as the last SOURCE contact (not the last 6-month follow-up phone call in which an FUQ is completed).

The COQ may be referred to for documentation of whether the participant has completed vaccination (both doses of a two-dose vaccine or one dose of a single-dose vaccine).

Please answer every question on this form. *NOTE: All response options in the paper form may not appear in CDART (e.g., 'Don't know', 'Declines to answer', etc.).* Beside each item input is a small double bracket icon which looks like this: . Clicking this icon displays a field dialogue box in which the "Field Status" selection menu allows you to choose from the following options: 'Refused', 'No response', 'Doesn't know', 'Not applicable', 'Maximum value', 'Minimum value', and 'Missing'. **See MOP 6 – Section 3.2 for additional instructions on how to select a Field Status option.**

Whenever numerical responses are required, enter the number so that the last digit appears in the rightmost box. Enter leading zeroes where necessary to fill all boxes (e.g., enter 0.25 rather than .25).

### II. INSTRUCTIONS FOR INDIVIDUAL ITEMS

**Header Information:** Consists of key fields which uniquely identify each subject and recorded occurrence of a form. For the "ID NUMBER", record the 3-character, 6-digit number assigned to the specific participant. For the "Event", record if this is happening at a follow-up visit or another event.

**Item 0a.** Record the date the data was collected or abstracted in the MM/DD/YYYY format either by selecting the pop-up calendar in CDART or entering the date in the space provided.

**Item 0b.** Record the SOURCE staff code of the person who collected or abstracted the data. This code is assigned to each person at each site by the GIC. If you do not have a staff code and are collecting SOURCE data, please contact the GIC in order to receive your own individual staff code.

**NOTE: Read the script preceding Item 1 to the participant.**

**Item 1.** Select only one option among the three possible choices. If 'No' is selected, go to Item 20.

**Item 1a.** Record the date the participant knows or thinks they had COVID-19 the first time since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are**

**requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**

**Item 1b.** Select only one option among the three possible choices.

**Item 2.** Select only one option among the three possible choices.

**Items 3-4.** Select only one option among the two possible choices.

**Item 5.** Select only one option among the two possible choices. If 'No' is selected, go to Item 9.

**Item 6.** Select only one option among the two possible choices.

**Item 7.**

**Items 7a-7c.** Select only one option among the two possible choices.

**Item 7d.** Select only one option among the two possible choices. If 'Yes' is selected, go to Item 7d1.

**Item 7d1.** Specify other type of COVID-19 test in the space provided.

**Item 8.** Select only one option among the two possible choices.

**Item 9.** Select only one option among the three possible choices. If 'No' is selected, go to Item 17.

**Item 9a.** Select only one option among the three possible choices.

**Item 9b.** Select only one option among the five possible choices.

**Item 9c.** Record the date the participant knows or thinks they had COVID-19 the second time since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**

**Item 9d.** Select only one option among the three possible choices.

**Item 10.** Select only one option among the three possible choices.

**Items 11-12.** Select only one option among the two possible choices.

**Item 13.** Select only one option among the two possible choices. If 'No' selected, go to Item 17.

**Item 14.** Select only one option among the two possible choices.

**Item 15.**

**Items 15a-15c.** Select only one option among the two possible choices.

**Item 15d.** Select only one option among the two possible choices. If 'Yes' is selected, go to Item 15d1.

**Item 15d1.** Specify other type of COVID-19 test in the space provided.

- Item 16.** Select only one option among the two possible choices.
- Item 17.** Select only one option among the two possible choices. If 'No' is selected, go to Item 18.
- Item 17a.** Select only one option among the two possible choices.
- Item 18.** Select only one option among the two possible choices. If 'No' is selected, go to Item 20.
- Item 19.** Record the number of days it took the participant to recover from COVID-19 in the space provided.
- Item 20.** Select only one option among the two possible choices. If 'No' is selected, go to Item 21.
- Item 20a.** Select only one option among the five possible choices. If 'Other' is selected, go to Item 20a1.
- Item 20a1.** Specify other COVID-19 vaccine in the space provided.
- Item 20b.** Select only one option among the two possible choices.
- Item 20b1.** Select only one option among the two possible choices.
- If 'Yes' is selected and 'One' is selected in Item 20b, go to Item 20b2; then, go to Item 21.
  - If 'Two' is selected in Item 20b, go to Item 20b2; then, go to Item 20b3; then, go to Item 21.
- Item 20b2.** Record the date of the participant's first COVID-19 vaccine dose since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**
- Item 20b3.** Record the date of the participant's second COVID-19 vaccine dose since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**
- Item 21.** Select only one option among the two possible choices. If 'No' is selected, **Go to End** of the form, and **Save and Close** the form.
- Item 21a.** Select only one option among the five possible choices.
- If 'One' is selected, go to Items 21a1 and 21a2; then, **Go to End** of the form, and **Save and Close** the form.
  - If 'Two' is selected, go to Items 21a1 and 21a2; then, go to Items 21a3 and 21a4; then, **Go to End** of the form, and **Save and Close** the form.
  - If 'Three' is selected, go to Items 21a1 and 21a2; then, go to Items 21a3 and 21a4; then, go to Items 21a5 and 21a6; then, **Go to End** of the form, and **Save and Close** the form.
  - If 'Four' is selected, go to Items 21a1 and 21a2; then, go to Items 21a3 and 21a4; then, go to Items 21a5 and 21a6; then, go to Items 21a7 and 21a8; then, **Go to End** of the form, and **Save and Close** the form.

- If 'Five' is selected, go to Items 21a1 and 21a2; then, go to Items 21a3 and 21a4; then, go to Items 21a5 and 21a6; then, go to Items 21a7 and 21a8; then, go to Items 21a9 and 21a10; then, **Go to End** of the form, and **Save and Close** the form.

**Item 21a1.** Select only one option among the five possible choices. If 'Other' is selected, go to Item 21a1a.

**Item 21a1a.** Specify other COVID-19 vaccine booster the participant received first since their last SOURCE contact in the space provided.

**Item 21a2.** Record the date of the participant's first COVID-19 vaccine booster since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**

**Item 21a3.** Select only one option among the five possible choices. If 'Other' is selected, go to Item 21a3a.

**Item 21a3a.** Specify other COVID-19 vaccine booster the participant received second since their last SOURCE contact in the space provided.

**Item 21a4.** Record the date of the participant's second COVID-19 vaccine booster since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**

**Item 21a5.** Select only one option among the five possible choices. If 'Other' is selected, go to Item 21a5a.

**Item 21a5a.** Specify other COVID-19 vaccine booster the participant received third since their last SOURCE contact in the space provided.

**Item 21a6.** Record the date of the participant's third COVID-19 vaccine booster since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**

**Item 21a7.** Select only one option among the five possible choices. If 'Other' is selected, go to Item 21a7a.

**Item 21a7a.** Specify other COVID-19 vaccine booster the participant received fourth since their last SOURCE contact in the space provided.

**Item 21a8.** Record the date of the participant's fourth COVID-19 vaccine booster since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**

**Item 21a9.** Select only one option among the five possible choices. If 'Other' is selected, go to Item 21a9a.

**Item 21a9a.** Specify other COVID-19 vaccine booster the participant received fifth since their last SOURCE contact in the space provided.

**Item 21a10.** Record the date of the participant's fifth COVID-19 vaccine booster since their last SOURCE contact in the MM-YYYY format by entering the date in the space provided. **NOTE: In instances that only the approximate month and year are requested, the calendar icon cannot be used in CDART (i.e., the icon will be crossed out with an X).**

Select **Save and Close** at the bottom of the page/screen.
